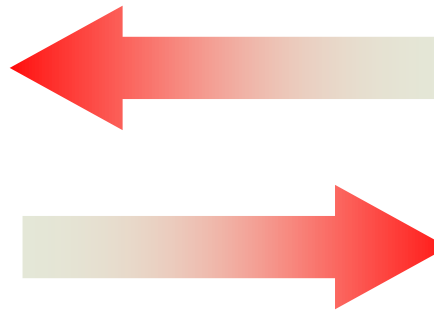


- Documents stored in the electronic document archives are easily accessible via internet

# SOLUTION: Electronic Document Archives

Justice archives  
such as:

Register



Sovereignly run electronic  
document archives of  
public corporations, such

The data contents saved in the electronic document archives are regarded as an original of the document ("original fiction") up to the proof of the opposite.

Highly secured long-term archives where originals can be kept for a long period.

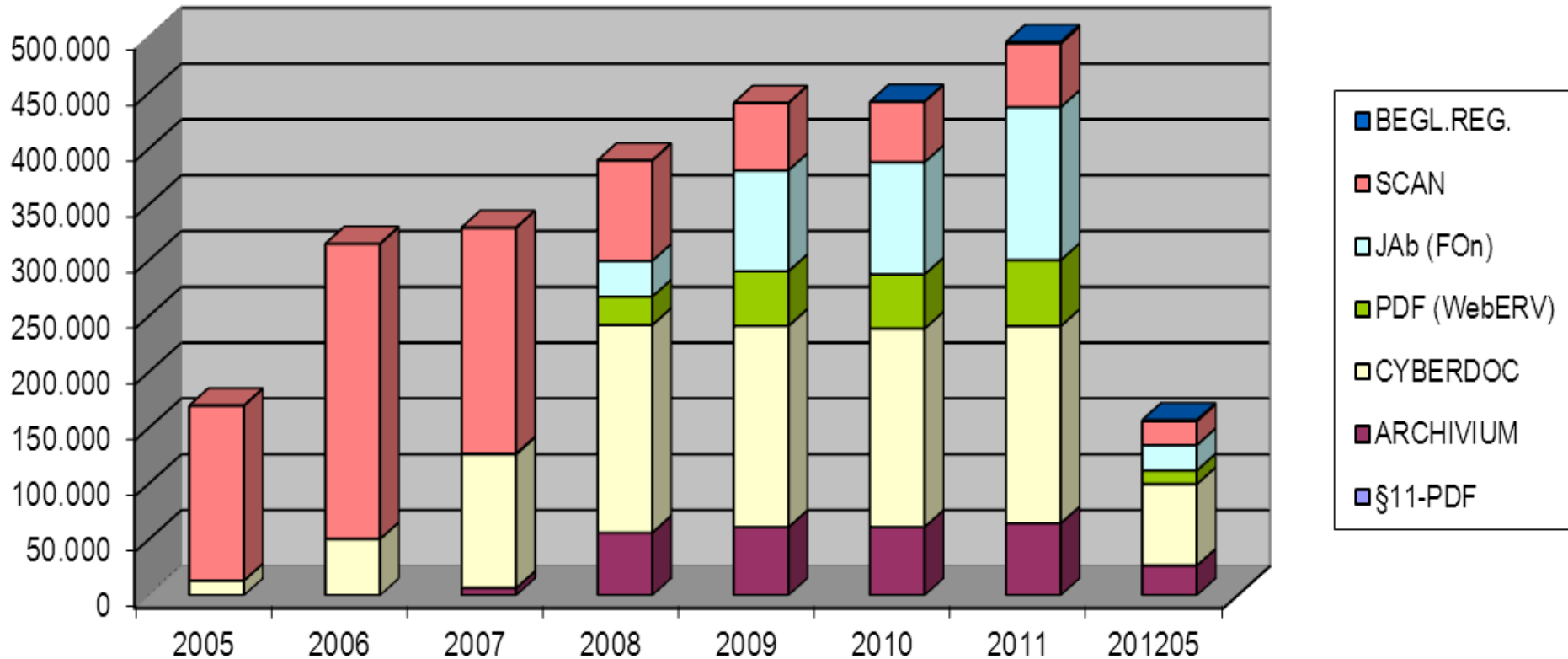
## Number of Documents

- Cyberdoc – notaries archive: 3.4 M
- Archivium lawyers archive: 1.4 M
- Court Archives
  - Land register: 6.7 M
  - Commercial register 2.7 M
  - Legalisation: 6 T
- **Total: 14,2 M**

- High Security
- Same legal status of electronic and Paper documents
- Long term preservation of court documents with legal force
- No risk of expiring signatures, no need of re-signing
- Speeding up procedures
- Reduction of costs

- Authenticity and integrity is secured and proved by archive signatures, applied when recalled from the archive
- Different ways to exchange documents:
  - Reference to archive (document code)
  - Attachment in ELC (Electronic Legal Communication)
- Interoperability of the different eArchives
