## **Apostille in Republic of Korea**

- Ratified : 25 Oct. 2006 / Effective : 14 Jul. 2007
- 2 Korean Departments working hand in hand in Apostille
  - Ministry of Justice(MOJ)
     & Ministry of Foreign Affairs and Trade(MOFAT) (Co-operating Apostille Unit in Seoul downtown)
  - MOJ : Notarized Documents MOFAT : Other Government Documents








# **Apostille in Republic of Korea**

- Apostille in Korea is relatively new, but expanding rapidly.
- About 70% of Apostilles issued by Ministry of Justice
- 203 Apostilles issued per day
   138 (MOJ) / 65 (MOFAT)
- Apostille Unit in MOJ
  - Issuing started in Feb. 2009
  - Increasing 20% per year

     (2012 UN Department of Economic & Social Affairs)





### The best condition in implementing e-APP!!

- We have Know-how to implement e-APP
  - We already adopted e-Notarization in Aug. 2010
  - Korean notaries can provide authentication of e-Document or digitalized Document in the form of PDF files
  - Implementation of e-APP will trigger more frequent usage of e-Notarization and vice versa.

지적재산권의 보호 강화 전자공증을 통해 독창적인 보고서나 올라인에서 파일형식으로 청조되는 다양한 콘텐츠에 대한 지적재산권이 보호됩니다.

중요 파일 20년간 보관 계약서나 영수증 등 장기 보관이 필요한 중요한 중이문서나 파일을 20년간 보관할 수 있어 큰 편약을 제공합니다.





### The best condition in implementing e-APP!!

Increasing electronic public documents

 Korean government provides e-Public Document service (Ministry of Public Administration and Security, MOPAS)

About 82 kinds of e-Public Documents issued such as 'Certificate of Resident Registration' via internet



# Korea's Plan of Introducing e-App



## Korea's plan of introducing e-APP

#### Phase 1 : e-Register

- MOJ and MOFAT to cooperate to develop e-Register system
- Need to secure budget and more staffs
- May 2013 : Pilot program to be operational
- July 2013 : Korean e-Register system to be launched

#### Building an Advanced Database

- Digitalization of the entire Apostille documents
- Accessibility of Digitalized Apostille documents
- Arranging huge amount of documents more easily



## Korea's plan of introducing e-APP

**Phase 2 : e-Apostille** 

Make the best use of e-Notarization experience such as electronic signature and security issues

From 2015 : Full Implementation of e-Apostille

Provide one-stop service of e-Public Document & Apostille

Problems of security & privacy should be solved



## **Our efforts to introduce e-APP**

- Lesson to be learned from other partners advancing in e-APP
- Budget, Budget and Budget !!!
- Inter-government Cooperation to provide one-stop service
  - MOFAT : Operation of e-APP system
  - MOPAS : Maintenance & Issue of Public e-Document
  - Supreme Court of Korea : Certification of Court Ruling and other Significant Document
